BI-CENTENNIAL PARK

On 23rd July, the Minister for Public Works and Parks, Laurie Brereton announced that the Maritime Service Board Workshop would not be built on the Annandale side of the Bi-centennial Park and that the land swap proposed had been scrapped. He instructed the M.S.B. to consult with the parks environment, the M.S.B. industry, and Leichhardt Council to determine future use of the land.

Being uncertain as to what the announcement meant

1. the whole site was now available for park; or
2. None of the site was available for the park.

We sought clarification. We learnt that for the moment none of the site had been secured for the park.

Three of our members (Tony Larkum, Neil Macindoe and John Buckingham) joined a deputation to express our concern to our local member, Pat Hills. He assured us of his continued support for the park, and will try to organize a meeting for us with Laurie Brereton. Our most recent information suggests that the entire site proposed for the Bi-centennial Park will become available, but there may be a trade off in the form of a marina on the northern shore of Rozelle Bay. Naturally we receive with joy the the information that the entire site is likely to become available for the park. However, we will demand that any marina proposed enhances the amenity provided by the park, and in no way detracts from it. We will be particularly alert to the effect the marina (or any trade off proposal) has on traffic, parking, noise.

ANOTHER WENTWORTH PARK

Members will recall the plans to "improve" Harold Park at a cost of \$5 million, approved by the present Council. Leichhardt Council now plans to lease substantial areas of Federal and Jubilee Parks to the NSW Trotting Club for carparking, initially for five years.

Attendances at Harold Park have been gradually declining, and there are other indications as well that the "industry" is dying. In the United States attendance at trotting and greyhound tracks is also very low, as punters save themselves the entrance fee and parking problems and watch races on the telly. NSW Government policy of providing massive grants (\$25 in Glebe alone) for tracks that are already the pariahs of racing in this state would not appear to be very sensible, therefor:

Leichhardt Council's attempts to prop up Harold Park are equally misguided. The parking area inside the track is never full, and parking is also available near the tramsheds. Council, however, prefers to encourage punters and bookies to use a public park, and hopes to raise about \$6000 in the process. At the same time as Council is giving away open space for carparks, it is supposed to be arguing for more open space on Rozelle Bay for a Bicentennial Park, since the Municipality has the third lowest proportion of open space in the Sydney region.

The consequences of this policy can already be seen at Wentworth Park, where large areas are used for carparking, and are consequently useless for other purposes. Areas at the edge of the Park are now used all day as carparks, in addition to race meetings, public transport strikes, and other great events.

The areas of Federal and Jubilee Parks Council intends to lease are not the most beautiful sections of these parks, and both have been used as carparks before. The Jubilee Park section is an asphalted area next to the goodsline off Maxwell Road. It serves mainly

as a velodrome for teenage bike-riders and a lookout over Johnston's Creek for strollers. A gunman used it as a shooting range earlier this year when he tried to kill an off-duty policeman after a race-meeting earlier this year. In 1984 the Society supported a proposal to turn this area into tennis courts, but nothing further was heard.

The section of Federal Park is the area between The Crescent and Johnston's Creek, used mainly by joggers, dog-owners and more determined walkers. The combined area is about 8000²

Both the Glebe Society and the Annandale Association have opposed the leasing of public parkland to the NSW Trotting Club before, but this time, with your help, we believe we can succeed in putting an end to this unnecessary, destructive and corrupting practice. INSTITUTE FOR THE CONSERVATION OF CULTURAL MATERIAL INC.

(Extract) Is concerned with the long-term preservation of the nation's cultural collections. These collections are deteriorating due to ignorance and neglect, even if aware of the problems, conservation work is unable to be carried out due to lack of facilities and trained conservators. The I.C.C.M. is equally concerned with historical structures and sights.

With Bicentenary only fifteen months away the I.C.C.M. has introduced 'Conservation on the Move', a state wide conservation service for local government and community, to highlight the importance of our cultural heritage.

Over the next eighteen months it is the I.C.C.M.'s intention to assist as many local Municipal Councils, educational historical, religious and business organisations as possible. We intend to hold seminars and workshops related to the general care of collections and individual items. The workshops will be run by conservators currently employed in public museums, galleries, libraries and in private areas. PALM TREES

Four mature palms, probably aged about 80 years, were removed from the Homoeopathic Hospital's vacant block on the corner of Glebe Point and Wigram Roads on Thursday morning, 23rd October.

The palms have allegedly been sold to the Darling Harbour Authority and are reported to be in the care of Alpine Nurseries. The Society attempted to have them retained, but the Heritage Council would not conserve them as most were not native and they were not associated with an outstanding building. The Society has photographs of the palms and will attempt to keep track of them. The Hospital sold the palms (no details are available) rather than move the proposed hospital block back about two metres from the road. The Board has promised to plant new palms of the same species.

The Society is concerned that any mature trees should be removed from our area, and feels that it is totally inappropriate that areas under great environmental pressure, as is Glebe, should be denuded to gratify the grandiose schemes of politicians.



PLAYGROUND EQUIPMENT

For many years, maintenance of playground equipment in Glebe's parks has consisted largely of a coat of paint. At the beginning of 1986, in the David Street playground in Forest Lodge, a small child was concussed when a rusted bolt broke and a swing collapsed. The resulting outcry from exasperated parents and other residents has led to a change of attitude on the part of Leichhardt Council. The dangerous climbing frames have been removed from playgrounds and the Deputy Engineer, Peter Head, has assured the Society that money has been allocated for new, safe equipment to be introduced beginning in the new financial year, and that residents will be consulted before it is installed.

This of course does not relieve Council of the responsibility of ensuring existing equipment is safe. Please report damaged equipment or injuries to children to the Deputy Engineer or to Ward Aldermen.

ILLEGAL DEMOLITIONS AND BUILDING

Two Victorian single-storey terraces in Burton Street have been completely gutted prior to receiving Council redevelopment consent.

As a result, Council has apparently revoked consent. There is no doubt that a very pro-development approach, such as that now being taken by the present Council, is a dangerous one to adopt in a conservation area such as Glebe, no matter how strong the controls. It encourages developers to believe these controls will not be enforced.

The approval of advertising signs and unsightly facades and additions also encourages developers to believe Council is indifferent to the appearance of the area.

THE PINK PANTHER STRIKES AGAIN


The bright pink paint which is the trademark of the Pink Panther Printers was acceptable on the commercial building which they used to occupy on the corner of Ross Street and Parramatta Road. When the same pink paint was used on the raw brick of the old building on the corner of Derwent Street and Parramatta Road, it was a different matter. The building is now an eyesore. Surely pink woodwork or a pink fascia would have sufficed and could have been repainted in a more suitable colour when the building's occupants change.

Presumably no planning permission is needed for paintwork. If this is the case, a code of acceptable colours, such as those used on the Glebe Estate, should be implemented and enforced.

DARLING HARBOUR (COCKLE BAY) CARPARKS

When proposals for Cockle Bay were first announced the emphasis was on attractions and facilities.

There was to be plenty of open space, a chinese garden and a lake with water organ. There was no casino, just an international hotel; no monorail running through the city, but a "people mover" to link the various attractions.

Even at that early stage the State Government had freed itself from the planning controls it itself had enacted, and the temptation to indulge in a variety of projects likely to cause greater problems if sited elsewhere became overwhelming.

From the beginning the Society argued that the site has poor road access. The freeways soaring overhead were the result of a grandiose and costly system begun too early by an impatient D.M.R. Had they waited a few years, the goods yards would have disappeared and the roads could have been built cheaply and unobtrusively at ground level. A short tunnel under Pymont peninsular could have linked them to Victoria Road, instead of the vast land-consuming eyesore now proposed. The freeways now give no direct access to the development site.

The Society therefore supported effective links with the existing public transport system using existing goodslines. In this way those visiting the new attractions would have an alternative to the narrow congested roads that presently provide the only access.

Since the route of the proposed monorail was announced it has become clear that the original conception for Cockle Bay has been drastically altered. It has now become a series of vast parking lots and stations, probably the largest anywhere. About 6000 car parking spaces are currently planned to be provided by Government, and a number of private developments must be added to these. The most recently proposed car park will be built in the huge woolstores adjacent to the site in Pymont : it will be the largest in Australia at 1600 vehicles.

This project has just been exempted from State planning controls (24 Sept.)

The "people mover" is now simply a shuttle for commuters and shoppers who will park at Cockle Bay and catch the monorail into the City. The monorail connects not with public transport but with major retailers. This will no doubt help to ensure its profitability.

It has now become clear that this enormous increase in available parking in the City area is to be matched by roadworks encouraging people to drive in from long distances. Unfortunately, these roads will not be ready when the carparks are. For example, a replacement Glebe Island Bridge cannot be ready in less than six years from now. In its present form, the Cockle Bay project is therefore likely to increase traffic congestion in the inner city for a considerable time. The construction of the monorail will at the same time reduce the capacity of many city streets permanently.

REFORM THE NRMA

For many years now the NRMA Council has been dominated by representatives trucking or transport companies and their supporters, most of them co-opted rather than elected.

It is not surprising therefore that the NRMA has pursued policies injurious to the Glebe and the inner city generally. These policies include inner urban freeways and the upgrading of inner city streets to encourage more traffic to enter the area. The NRMA has never expressed concern about the effects of traffic on the inner city or supported improved public transport.

Now a group of reformers, generally from inner city areas seriously affected by these policies, are trying to ensure we have a voice in this powerful organisation. If you have not voted already and receive your Bulletin before 7 November, please do yourself a favour and vote for the reform group by: striking out all asterisked candidates (current council members) except Parker, and strike out Wood.

ABSENTEE ALDERMAN

Al. Harry Mitchell, late of Lilyfield, has now moved to Melbourne. However he intends to commute to Sydney for enough Council meetings, now held only half as frequently (once a month), to avoid having to resign before the next Council election, to be held within twelve months.
