## WENTWORTH PARK SUB-COMMITTEE

The Society is determined to protect the interests of Glebe residents regarding Wentworth Park and the area surrounding it. We need someone living near the park to monitor the activities of the Wentworth Park Trust and to generally co-ordinate the Society's efforts in this area. Here are some of the things you could do:

1. Ensure the Wentworth Park Trust fulfils its obligation to landscape and plant out the area near the stand.
2. Discuss further landscaping proposals with the Trust, Leichhardt Council and the Ministers for Lands and Sport.
3. Suggest improved facilities and suitable activities.
4. Press for improved access for residents to the track and stand, and free community use of facilities.
5. Ensure that residents are not disadvantaged by parking, traffic or development proposals, especially during 1988.

## HAVE A HAPPY CHRISTMAS

**HISTORIC RECORDS**

S E A R C H

The aim of the Historic Records Search is to locate and record the existence of records held in private hands throughout Australia. The project is concerned to identify materials, not collect them or remove them from the communities in which they are held. A computer-based Register is being developed so that all Australians will know that an historically significant body of material exists in homes and offices across the nation.

The Register will comprise brief descriptions of materials held in private hands. It will list the names of the main people, businesses, community organisations, events, places and activities mentioned in the records.

**What will the Search register?**

The Search will be as wide-ranging as possible. It will record materials which document important events and places in Australia's history. At the same time, the Search will identify and record the papers of small businesses, community organisations and families.

The variety of records held in private hands includes: family papers - letters, diaries, photographs; minute books, financial records and correspondence in the case of small businesses or community organisations; and printed and published materials that have not found their way into public collections.

## Brereton scuttles plan for Rozelle Bay marina

The Minister for Public Works, Roads and Ports, Mr Brereton, appears to be clearing his plate of unpopular projects before next year's election.

This week Mr Brereton instructed the Public Works Department not to proceed with its proposed 247-boat marina in Rozelle Bay. Last week he called off plans for a tombolo and marina in Port Hacking.

Both schemes were resisted by strong resident-protest groups.

Mr Brereton told the Department to halt the Rozelle Bay marina plan until more work was done on how to dispose of heavy-metal residues from the harbour bed.

This followed local groups' concerns about the level of heavy metals such as zinc and cadmium.

Mr Brereton said the State Government would not proceed with the marina development application at this stage.

He said he had asked his department to study some new issues that had arisen since the marina development application was submitted to Leichhardt Council.

These included a new intersection at Johnson Street and The Crescent, Annandale, and the disposal dredged material.

A Save Rozelle Bay Committee spokesman, Mr Tom Dan, said the committee welcomed the Minister's decision.

He said the Public Works Department had sought to construct the marina without following the proper environmental impact statement procedures

### ROZELLE AND BLACKWATTLE BAYS

Now that it is clear that Stage I of the Bicentennial Park is to go ahead without the marina being a threatening pre-condition, (Brereton has in fact withdrawn the Development Application, pending further environmental assessment) the Glebe Society can afford to turn its attention to Rozelle/Blackwattle Bay as a whole. Although the Glebe Society has made submissions and has responded separately to proposals on the Bicentennial Park, the marina, the new Glebe Island Bridge and the container slip road, we now need to step back and assess the environmental impact of the many plans and proposals for separate parts of Rozelle and Blackwattle Bays.

The following list represents sites for which there are firm plans, proposals or constant rumours:

- \* the Bicentennial Park
- \* the marina
- \* the container slip road
- \* the new Glebe Island Bridge
- \* Stride's Yard (Blackwattle Bay Park) - restoration and open space
- \* Venetia restoration
- \*\* Fletcher's (Forsyth Street)
- \*\* Council Depot (Forsyth Street)
- \*\* Marine Engineering (Cook Street)
- \*\* Hardy's (Glebe Point Road between 'The Anchorage' and Glebe Point)
- \*\* These four sites are all waterfront open space with low rise town house/unit development
- \* T.A.F.E. Marine College (on High School site)
- \* Fish Markets redevelopment (including restaurants, cafes and a 'boatel')

As well as considering each of the above planned/proposed/rumoured developments in the context of the others, we also need to consider them all in

Dear Ms. Doe,

I refer to your letter to The Hon. R.J. Mulock, M.P., Deputy Premier and Minister for Transport, concerning traffic management in the Glebe area.

At the outset let me say that I can appreciate the Society's concern that development and increased traffic growth in the Sydney Central Business District is having an adverse effect on the amenity of the Glebe area.

You would be aware that recently the Premier, The Hon. B.J. Unsworth, M.P., announced that the Traffic Authority of New South Wales had established a City Traffic Operations Centre (Traffic Watch) to closely monitor and improve traffic movement throughout the central city. The Traffic Watch organisation will be responsible for managing inner city traffic on a day-to-day basis and into the future by co-ordinating State and Local Government roadworks and the activities of building developments having an affect on traffic movements, parking, public transport operations and pedestrian flow.


Also, the Authority is preparing a study of the overall situation, the "Sydney Central Business District Traffic Management Strategy Study", which will co-ordinate the views of Local and State Government Bodies, Unions, the Taxi Council, professional organisations and citizen's groups who may be directly or indirectly affected by matters arising from traffic in the area.

You will appreciate that this study will take some time to complete.

Should the Glebe Society wish to have submissions to the study considered by the Traffic Authority, it is suggested in the first instance that these be made by representations to Leichhardt Municipal Council.

It is proposed that any traffic management plan for the City resulting from the Study will be placed on public exhibition prior to finalisation.

Here is an outline of several planning matters that are concerning residents in various parts of Glebe. The residents appear to be well organised and in no case has the Society had more than an advisory role.

1. 208 Bridge Road - 10 Jarocin Avenue. Two noisy factories are operating without Council consent. Unfortunately the previous Council seemed much more willing to listen to the operators than the residents. Still unresolved.
2. Harold Park cooling tower. The air-conditioning system for the renovated grandstand has caused residents on the cliff-top great concern. To date, the N.S.W. Trotting Club has refused to insulate it and Council has supported the Club rather than residents.
3. Residents have requested the closure of Lyndhurst Street at its intersection with Pymont Bridge Road to reduce the volume of through traffic.
4. Residents in the St. Phillips area of the Glebe Estate have requested more open space. To date none has been provided by the Dept. of Housing and Council has opposed all suggestions.

- \* The large Meloy's site that spreads from Ferry Road to Lombard Street has been sold to Carl Spies, redeveloper of 'The Swifts', Darling Point.
- \* The old tram sheds behind Harold Park belong to the Urban Transport Authority, which is trying to dispose of them. Since they would form a valuable depot for a light rail system using the goods lines, members are requested to write, requesting their retention, to:

PROPOSALS FOR 198 - 206 ST JOHNS ROAD

The Heritage Council has called for comments on a proposal involving the preservation of all of 206 and the facade of 204, but the demolition of 198 and 202 and their replacement with 2 storeys of shops and offices plus basement parking. The proposal also includes reflective glass and concrete hoods. The Society has written pointing out the objectionable aspects of the proposal but noting the progress that has taken place.
