HOUSE INSPECTION - SUNDAY 30th OCTOBER

Planning for the house inspection is just about complete.

In addition to the nine buildings listed in the last Bulletin, there are now five private homes which have been generously offered by members. The Hermitage, in Bridge Road, an important building by Reuss, has been made available by a group who are not members of the Society (yet).

The Demeter Bakery group are also enthusiastic to be involved. They may include Harkness Studio, which was once Glebe's silent picture theatre.

A poster has been designed as a project by Randwick TAFE Graphic Arts class. It has now been printed and should be seen in shops around the suburb. A poster is enclosed with this Bulletin. It is not for your fridge but is for promoting the event anywhere you think people interested in coming to the inspection will see it.

A guide booklet to accompany the tour is in the final stages of preparation. It will be an expanded version of the walking guide printed by the Society some time ago.

The new guide will contain a number of illustrations, including two which have been especially commissioned for the occasion. It is hoped that the new guide will provide an attractive presentation of our suburb to a large number of people who ask the Society and local bookshops for information on Glebe.

If there is a favourable response to the guide, it will be reprinted and sold through local bookshops.

Two members have advanced the cost of the first two illustrations. These "loans" are to be repaid from future sales of the guide. If the reprint is to be better than the first edition all it will need is more illustrations.

If you wish to sponsor a drawing of your favourite building, or know a business which will come to the party contact Jeff Ibbotson now. You may get your money back sooner than expected if sales are good.

The committee is considering using six of the illustrations from the guide for a calendar. Before committing the Society to this expenditure we need a response to gauge the feasibility of such a venture.

There has been a steady flow of offers to mind buildings. But there are still plenty of vacancies. We need people to walk around and keep an eye on the building. We need some to sit at the door to check tickets and some to sell tickets at Lyndhurst and Hereford House. There will be time for minders to see other buildings. Of course, each minder receives a free ticket and guide.

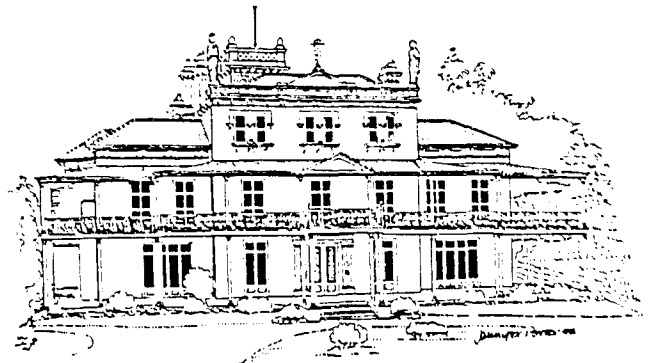
The ticket will list the buildings which are open and provide a suggested route, which will be marked on map to be printed on the ticket.

The guide will provide a description of important buildings, many of which will not be open, but which are on the route. It will have a more detailed fold out map.

We hope to have tickets ready for sale at Gleebooks from 15th October. The guide can be collected by ticket holders on the day from Lyndhurst or Hereford House, on presentation of their ticket. Tickets will of course be sold on the day at these two buildings.

So, remember to bring your friends to this important event for the Society. Lunch and morning and afternoon tea will be available at St John's, Rostihaus, The Pudding Shop, Ragtime and Cafe Troppo. Take your daily bread at Demeter Bakery. Listen to the organ recital at St John's at 3 pm. With all of that, there may be barely time to see the buildings! You would be best advised to start out soon after 10 am, especially as St Scholastica's will only be opening Toxteth House in the morning (the grounds are open all day).

GLEBE ISLAND BRIDGE

Several members of the Society visited the DMR's offices in Castlereagh Street on 22 September at the invitation of the Department, to inspect and discuss plans for a new Glebe Island Bridge.

The Society is not enthusiastic about the prospect of a high level bridge so close to residential areas of Glebe. However, if there is to be a bridge, the new one being planned has attractions as a design.

Members were pleased to learn that the DMR plans to coordinate the construction of the west-bound access road on to the new bridge from Ultimo with the building of the bridge itself - a stayed cable design. This alleviates to some extent one of the serious concerns the Society has had up to now - that the bridge would be the last element of the road system to be completed and that Glebe would suffer major traffic overloads in the period between completion of the new arterial roads and the construction of the bridge.

Planned access roads at the western approaches to the bridge, however, leave much to be desired. The obnoxious container truck loop road into the Crescent is still planned (with its concomitant infilling of the end of

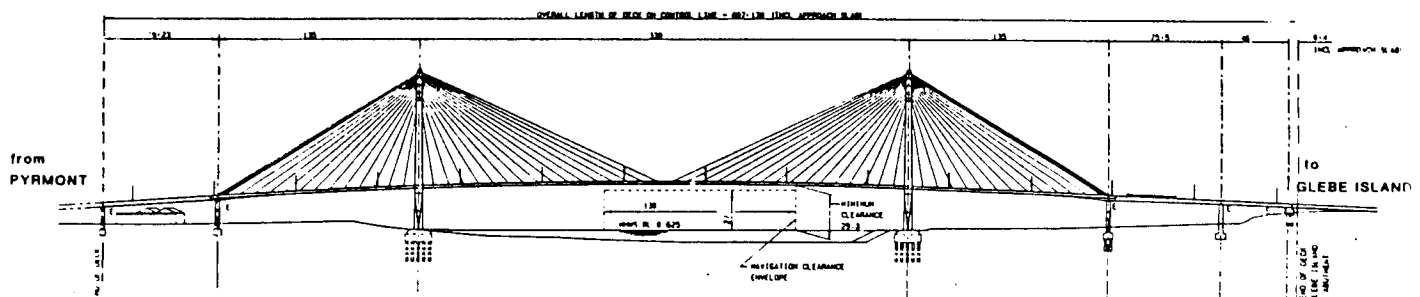
Rozelle Bay). This design partly results from the requirements of the Maritime Services Board and from the fact that the DMR cannot influence the MSB to any extent.

The Society believes that what is required is a complete redesign of the Glebe Island area to incorporate a road that would be both an access road to the new arterials and a service road for the MSB's operations on the Island. The opportunity for and timeliness of a coordinated plan for the area is underlined by the anticipated closure in the near future of the grain handling facilities at Glebe Island which would enable the MSB to review its needs, operations and facilities on the site.

The model bridge, photographs and plans are on display in the Castlereagh Street Office of the DMR until 24 October. Members are urged to try and call in and view the proposals. We should be interested to have your comments or copies of any letters you may feel impelled to write.

The Management Committee is seeking to pursue with the Government the question of an overall plan for Glebe Island and adjacent areas - with particular reference to road design plans.

AN INTERVIEW WITH THE PRESIDENT - Extracts from the article by Catherine Lumby in The Eastern Herald, 13th October 1988.

In Leichhardt, where a heritage study is under way, powerful conservation groups oversee any structural alterations to houses in the municipality and submit their recommendations to the council. Botany Council, in contrast, makes no provision for conservation in its local environment plan.

In Glebe, the Glebe Society takes an active role in preserving what it sees as the unique historic, architectural and social environment. Recognition of Glebe's heritage value is also built into the local council's stringent local environment plan.

The president of the society, Mr Peter Strickland, praised Leichhardt Council's stance on conservation. "They're usually very sympathetic to our concerns," he said.

Mr Strickland outlined the society's methods for overseeing development in the area. "Firstly, we monitor every development application which goes to the council and make a report if necessary. Secondly, we simply walk around the area and take note of any alterations which are going on."

The society's main concern is to prevent alterations to the existing

character of buildings or to the streetscape.

Yet the attention of the Glebe Society is not always welcomed by residents. One recent beneficiary of its scrutiny referred to members of the society as "a pack of yuppies who only care about their real estate values".

"These people have gained control of what was a working-class area and are trying to push their values on to everyone. A lot of us here aren't that rich. Simply having a house is more important than how it looks," he said.

Council set to fight plan to sell Harold Park for housing

Leichhardt Council is gearing up for a battle over plans to sell the Harold Park Raceway and rezone it for housing.

The site, which is owned by the Harness Racing Association, covers nearly three hectares of prime land in the inner-city suburb of Glebe.

Selling the site could raise between \$70 million and \$100 million for the association. This is earmarked to move trotting and harness racing to a new site in Homebush, the State Government announced yesterday. (Full report: Page 5)

Leichhardt Council's town clerk, Mr Tony Woodward, said the land was zoned as open space for sports and recreation, and should remain that way.

"Leichhardt's planning scheme has, since the early 1970s, envisaged that the Harold Park site would remain open space," he said yesterday.

"We imagine that there would be fairly heavy opposition to a rezoning which would allow any development on that site which would erode green space."

Mr Woodward said there were already too few "green spots" in Leichhardt.

"If you look at the overall picture you see that the municipality does not have that many open space green areas. People who created the plan many years ago held the view that that site should stay green, not be developed."

Mr Woodward said the council had not yet received a firm proposal for rezoning from the Harness Racing Association. It was told of

plans to sell the track on Tuesday.

"We have seen nothing concrete ... but there is sure to be a 'yike' about it from residents.

"The point is that it really does not appear to be fair to make a decision like this that will affect, and be done at the expense of, local residents."

According to a spokeswoman for the Department of Environment and Planning, a site of similar size to the Harold Park Raceway could hold 60 small detached courtyard homes.

"If the density was raised and townhouse-style development was envisaged then about 100 dwellings could be built to house about 400 people," she said.

According to this article, the cost of the land only would be \$700,000 to \$1,000,000 for each of the 100 smaller dwellings. We'll be getting some very classy neighbours.

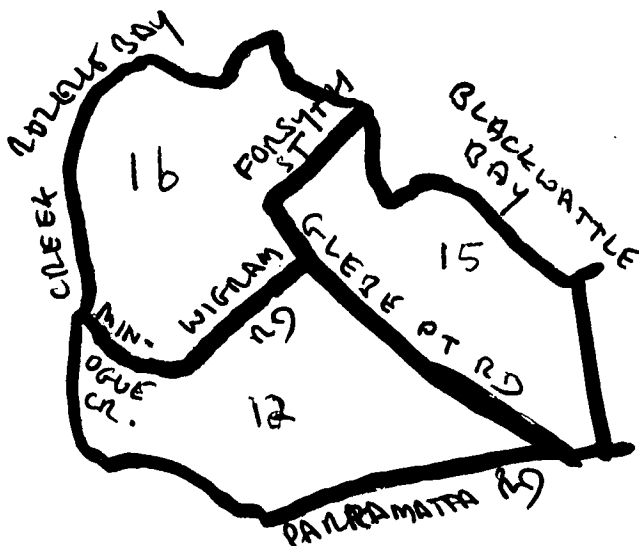

ENVIRONMENTAL CRISIS - PLEASE WRITE NOW

The above groups have combined to write to the Society:

... We are fast approaching an environmental crisis in NSW. A strong public expression of outrage is vital if we are to convince the Coalition government that it is on THE WRONG TRACK.

... We sought and were granted an urgent summit meeting with the Premier. Despite the fact that Mr Greiner has reiterated his commitment that his government will be 'green' it is clear to us that the Premier needs an avalanche of protest letters. He has to be convinced that the direction of the government's policies is completely unacceptable.

We therefore ask you as a matter of urgency to write to the Premier expressing your strongest objections to these policies

The Glebe Society Committee urges members with particular concerns about or knowledge of environmental issues to write to Mr Greiner, with copies to the Glebe Society and the Nature Conservation Council (176 Cumberland Street, Sydney) of all letters and responses. Some major environmental issues are:

- * the failure to acknowledge the need for State government responsibility for planning to ensure environmental protection.
- * sale of remnant urban bushland for residential development in already urbanised areas (eg Lane Cove).
- * calls for tenders for private tollways in both urban and rural areas without a prior assessment of the environmental impact of the route.
- * redefinition of permissible activities in 'Environmental Protection Zones' and the sale of coastal Crown lands.

FAMILY SEARCH - STANDISH BARNCASTLE

Brenda Burke, a member of the Liverpool and district Family History Society, is researching the Barncastle family and branches from it. Standish Barncastle and his wife Elizabeth settled in the Glebe area in 1831. Their first child, Margaret, was born 15th September 1832 at Glebe. Later, Standish ran a shoemaker's business in Glebe Point Road, where he lived until his death in 1884.

Brenda has not been able to find when Standish arrived in Australia, or whether he was free, convict or military and wonders if any older Glebe residents can help, as Barncastle is not a common name.

More recent family members were Emily Field (nee Parsons) who died aged 82 in 1931 at 157 St Johns Road, William Roland Parsons, who died in 1912 aged 66, and Walker, Platt, Young and Bailey families.
