GLEBE POINT ROAD PROJECT

The committee for the revitalisation of Glebe Point Road will hold its first public meeting on Wednesday 21 June. This launch of the project will be held in the old fire station on Mitchell Street and will consist of light refreshments followed by a brief presentation of the process we will follow in drawing up a plan for Glebe Point Road.

The plan will address four main areas:

heritage and design business development improved community facilities.

Libby Ozinga from the Department of Planning will explain the MAIN STREET scheme administered by that Department while Lori Anglin, an urban design consultant, will outline a seminar on Glebe Point Road to be conducted the following week.

This looks like an interesting evening, 6pm to 7.30pm, and we hope as many Glebe residents as possible will pop in to contribute to the planning process.

GLEBE FOUNTAIN

The fountain at the junction of Glebe Point Road and Parramatta Road was erected in 1909 to mark the jubilee of The Glebe as a local council area. The Glebe Point Road Project Committee, with funds made available by the Glebe Street Fair Association, has taken the first steps to revitalise and restore this significant, but sadly neglected, historical piece. We see this as an appropriate and practical beginning to the Committee's plans for the physical improvement and conservation of Glebe Point Road, as part of the Department of Planning 's MAIN STREET program.

Our initial intentions are to get the water flowing, the light turned on and the surrounding area replanted and maintained. We hope to talk to the Council engineers this month and will keep members informed about our progress.

TRAFFIC MANAGEMENT STUDY

At the first meeting of the Leichhardt Council in 1988 a petition from the Glebe Society calling upon the Council to commission, as a matter of urgency, a traffic management plan for Glebe and the Municipality came up on the agenda at 2am. It was then referred to the Council's Statutory Traffic Sub-Committee.

In May the Sub-Committee met with residents, including representatives of the Society, and with a traffic consultant, Mr Michael Colston, of the consulting firm Colston, Budd, Wardrop and Hunt. The consultants presented an 'Inception Report' and, after another meeting in July, again attended by representatives of the Society and other residents, the Traffic Sub-Committee submitted this to Council with the recommendation that a full report be prepared.

After that, silence for many months, punctuated by inquiring telephone calls to the Chair of the Traffic Sub-Committee, Alderman Betty Leone, and to the Engineer's Office.

Now, however, twelve months after the first meeting with Michael Colston, residents' representatives have been able to review the consultants' Interim Report, dated March 1989.

Alderman Leone convened a meeting on 8 May at which residents commented on the options presented in the report These ranged from total closures, through partial closures to speed reduction measures. The draft report is likely to be a mix of these options chosen in the light of the input from the meeting. The draft report is expected to be available in four to six weeks from the meeting, i.e. by the end of June. It too will be circulated and a further meeting will be held before the final report goes to Council.

John Hoddinott, Angela Beagley and Jeanette Knox, who all attended the last meeting, have copies of the interim report should anyone wish to read it.

INCORPORATION MEETING

The subject of incorporation is not one that sounds inviting and only a handful of members turned up at our Special General Meeting to decide on a new constitution to progress the incorporation of the Society. Yet another cold wet evening didn't help.

Ted McKeown, who is something of an expert on constitutional matters, has noted some inconsistencies that could be overcome if the whole constitution were rewritten following Model Rules which provide a framework for societies like ours. Our present document has evolved over many years and is very much a cut and paste job, so with Ted's help we are using this opportunity to clean it all up.

The aim now is to present the new constitution at the Annual General Meeting which is scheduled for 23 August.

Twenty years ago the citizens of Glebe thwarted a plan by the State Government to send the western distributor through their suburb. Now the Glebe Society has an urban force of about 500 people on semi-permanent standby, ever ready to be mobilised for the cause of maintaining Glebe in its village-like state.

"We understand the importance of lobbying the right people," Mr Strickland said. "We always aim to make positive suggestions. We don't just say, 'No we don't want that, we try to come up with an alternative.'"

Despite recent losses, including the Rozelle Bay marina, where Leichhardt Council has given the go-ahead for a 214-berth marina, Mr Strickland agreed the society had not been doing much of what he called "old-style" campaigning. It is not that the heady days of throwing oneself in front of bulldozers (or barges?) is a thing of the past, a tactic of more confrontational days. "If an issue came up, we would be prepared to do so again," Mr Strickland said.

A characteristic shared by rebellious residents is their complete disregard for and distrust of government and the bureaucracy. These people may be idealists but they are cynical idealists.

PLANNING REPORT

There is no further progress to report on a large number of issues, such as the Orphan School Creek Park, Harold Park, the old tramsheds, the Campbell's site in Junction Street and Sugar's Timber Yard. There is no agreement between developers and residents on the Hardys or Meloys sites.

The sub-committee has objected to the siting of a public convenience in the ballroom of Bidura (see copies of correspondence in the SMH this Bulletin). There are rumours of the possible closure of Sydney Homoeopathic Hospital at the corner of Glebe Point Road and Wigram Road, and of a deal between Leichhardt Council and the Children's Hospital on the use of a number of houses owned by the Hospital which Council has refused to allow to be demolished. The Saigon Pearl Restaurant has failed and yet another Thai restaurant, with an improved but still deficient paint scheme, is to replace it. Leichhardt Council is to prosecute the owner of the pair of Federation terraces opposite the Homoeopathic Hospital for converting them to shops without Council consent.

On Thursday 8 June the Heritage council advertised a proposal to restore University Hall to its original 1889 facade, including three storeys of iron balconies and the appropriate High Victorian decoration. remainder of the proposal is less appealing: 128 hotel rooms are arranged in seven storeys, rising to the same height as the five storey Hall, but not stepped down to the lower adjacent buildings. There are three floors of underground parking for 83 vehicles with entry from Glebe Point Road and a proposed exit to Derwent Lane. terraces and the billiard and dining rooms would be demolished. The sub-committee is awaiting a full copy of the proposal before making further comment.

There have been numerous expressions of interest in the recycling of Bellevue, the handsome villa in Blackwattle Bay Park. The Society is conducting its own evaluation of these varied proposals with a view to preserving the interests of residents and ensuring choice of the most acceptable proposal in terms of access and nature and level of use (see separate report).


WHAT TO DO WITH BELLEVUE

Leichhardt Council has begun to move seriously on Bellevue, the wonderfully sited Italianate villa built by Ambrose Thornley Jnr, saved by resident action, and now a prominent feature of Jarrett Point in Blackwattle Bay Park.

Council called for expressions of interest, which fall into two distinct groups. The first has only one proposal, for the headquarters of the Australian Society of Authors. The other group consists of eight restaurant/reception proposals of varying scale and complexity.

The main advantage of the Society of Authors proposal, apart from the restoration of Bellevue which is included in all proposals, is its modest scale and low impact on the park and local residents. As well as being larger and more disruptive, the commercial proposals include generally longer leases and, after some years, varying amounts of rental return to Council.

Council has now prepared a Brief which includes a public wharf to encourage waterborne access to Bellevue and reduce the impact of traffic flow and parking. The Society's Blackwattle Bay sub-committee considers that the most appropriate siting for a wharf is not Blackwattle Bay Park but the end of Glebe Point Road, which has much better land access. The sub-committee is therefore investigating a compromise scheme which would lease Bellevue to the Society of Authors for a moderate period but also include lease of the lower section, including the walled terrace, as a tearoom, thus providing a reasonable return to Council. Please make your views on such a scheme known to a member of the Society's Management Committee or any convenor.



Setting up to serve adult disabled

SIR: Your correspondent, Ms Barbara Bee (Letters, June 2), expressed concern about a proposal pinned to the fence outside Bidura Children's Court in Glebe for refurbishment of the premises and she questioned the priorities of Government spending.

Unfortunately, the sign in Glebe Point Road is misleading and the refurbishment is not, in fact, for the court at all.

The "refurbishing" which is in fact taking place is to the historic building which stands in front of the court facing Glebe Point Road. This building, designed and occupied by colonial architect, Sir Edmund Blacket, in the 1860s, is shortly to be occupied by the Guardianship Board of NSW.

The Guardianship Board is a newly established body, entirely separate from the Children's Court, which will assist adults who, as a result of serious disabilities, may require the appointment of a guardian or a financial manager to make crucial decisions on their behalf. It is an initiative which has the strong support of all major political parties.


The refurbishment, which is modest and sympathetic, involves little more than painting, rewiring and the provision of access for people with disabilities. It is a worthy use of a valued part of Glebe's and Sydney's heritage and carries a message that the people it will soon serve are also valued.

I hope that Ms Bee's and others' legitimate concern is allayed.

Roger West (SMH Thursday 8 June) makes reassuring statements to Glebe residents that the refurbishment of Bidura, once the home of the architect Edmund Blacket and his daughters, is "modest and sympathetic".

Herald readers should be informed that Mr West's proposal includes the siting of a public lavatory in the ballroom adjacent to the house. It may contribute to "modesty", but it is about as insensitive and unsympathetic a way to treat a historic building as it is possible to conceive.

Naturally The Glebe Society, the residents organisation, supports access for the disabled, and quite possibly the creation of a Guardianship Board for the disabled is a wise move. However, Mr West should revise his plans and locate the public convenience more appropriately to comply with his public statements.

A Course for Conservationists

Total Environment Centre has organised a course for conservationists covering three days, Friday 21 to Sunday 23 July 1989.

This is in response to the urgent need to provide information and training for community based environmentalists who will be in the front line in the 1990s in the increasingly tough and urgent battle to protect the environment.

The emphasis of the course in on practical information that can be used to maximise campaign effectiveness. Subjects to be covered include: sustaining a campaign; managing community groups; writing material; the media: and dealing with government. TEC has gathered a group of specialists in all these fields to participate in what promises to be a stimulating three days of lectures, discussion and workshops.
